## Marine Protected Area to be established

The UK's new coalition Government has indicated its intention to press ahead with the establishment of a Marine Protected Area (MPA) covering the Chagos Archipelago. The declaration of an MPA in the British Indian Ocean Territory was announced under the previous UK administration, in April, following a public consultation which attracted very wide support for the measure. Responding to a Parliamentary Question in the House of Lords on 29th June 2010, Lord Howell of Guildford (Minister of State, Foreign and Commonwealth Office) confirmed that "the intention to go ahead with the MPA is in place".

"The territory's quarter of a million square miles is Britain's greatest area of marine biodiversity," said Lord Howell, who went on to provide an assurance that "The territory's administration will work with interested organisations and regional Governments to increase awareness of the environmental and scientific importance of the territory".

The declaration of the new MPA does not, in itself, cost anything. However, there are concerns over funding to support management of the MPA, and to ensure that illegal fishing is prevented throughout the reserve. With regard to the cost of maintaining a patrol vessel for surveillance duties, Lord Howell noted that "The overseas territories division is in discussion

with a number of foundations and charities which have offered to meet that requirement for a five-year period."

The political context is complex, and needs to consider relations with Mauritius, which claims sovereignty over the Territory, and the Chagossian community, which is currently fighting in the European Court of Human Rights for its right to return to the islands.

UKOTCF made a submission to the consultation, supporting the MPA, recognising also that reconsideration of details would be necessary should exiled Chagossians ever resettle in the islands. UKOTCF therefore welcomes the announcement noting that, whatever the future arrangements for the Archipelago, it is sensible to conserve the exceptional marine systems - for their intrinsic value, for study, as a source area for the stocks fished off East Africa, and as a resource for sustainable use should there ever be resettlement.

## South Georgia Heritage Trust Habitat Restoration Project

The Government of South Georgia and the South Sandwich Islands have announced that, following stakeholder consultation, conditional approval has been given to the South Georgia Heritage Trust for the first phase of the Habitat Restoration project to proceed in February-April 2011. This first stage of the project aims to eradicate rats from the Thatcher, Mercer and Greene peninsulas on South Georgia, with later stages addressing the other areas. It is a major undertaking and, if successful, should result in a dramatic increase in the numbers of ground nesting birds, amongst other benefits. For more information see <http://www.sght.org>

## Invasive Species International

Landcare Research, an organisation which has supported many successful invasive species projects in New Zealand, established Invasive Species International (ISI) in 2008 in response to growing international demand for technical expertise and research services. In particular, they have been involved with the planning of mouse eradication efforts on Gough Island, Tristan da Cunha.

Their goal is to use their significant experience in the eradication or control of invasive plants and animals, and their extensive network of contacts to assist overseas organisations to achieve their invasive species objectives.

Following on from a conference held at the end of 2009, which was attended by several representatives from UKOTs, the ISI have produced a newsletter which may be of interest to those working on invasive species in the UKOTs.

## Post-Reunion Canaries meeting

## Post-Reunion Canaries meeting (Canarias2010)

At the Reunion conference in 2008, a follow-up meeting had been announced, to be held in the Canary Islands in 2010. This was being organised by the Canary Islands Government with support from IUCN, to take place in September, under the working title *Biodiversity and Climate Change in Islands: New Developments*. UKOTCF responded to a consultation in January with a note offering to support and participate in the meeting, despite concerns over timing, and offering to help facilitate input and involvement from the UKOTs. However, the meeting has now been cancelled for financial reasons in the changed economic climate. It is expected that a follow-up meeting will be organised in a later year.

There is likely to be continuing interest in the UKOTs in the new parliament. The Commons select committees on Foreign Affairs and on Environmental Audit published important overseas territories reports in the last parliament and are expected to return to the subject.

In addition to the Select Committees, there are also All-Party Parliamentary Groups (APPGs) for many territories. Apart from the Overseas Territories

APPG (Chair, Andrew Rosindell MP Conservative - Romford) there are groups for three SOWG territories: Chagos Islands APPG (Chair, Jeremy Corbyn MP, Labour - Islington North), Falkland Islands APPG (Chair Derek Twigg MP Labour - Halton) and St Helena APPG (Chair Bob Russell MP, Liberal Democrat - Colchester).

## Overseas Territories Environment Programme Awards 2010

The following projects in our region were awarded funding in the recent round.

### **An Action Plan for the Conservation of Falkland Island Rockhopper Penguins (OTEP FAL702)**

This project will produce a Species Action Plan for the southern rockhopper penguin in the Falkland Islands. It will progress priority conservation actions for this Vulnerable (IUCN 2009 *Red List*) seabird, with its rapidly declining populations, and will address recommendations from the International Rockhopper Penguin Workshop (2008) that have implications across its breeding range. The capacity of Falklands Conservation to advise government and industry on mitigation measures and undertake direct conservation activities will be substantially enhanced.

### **Maintaining the World Heritage Status of Henderson Island, Pitcairn Islands (OTEP PIT703)**

RSPB and partners are preparing for an operation to eradicate rats from Henderson Island. This project will provide resources to employ and equip the leaders of an expert eradication team. If the operation is successful, it will contribute to preservation of the island's World Heritage status and secure the long term future of Henderson's endemic wildlife and breeding seabirds which are threatened by Polynesian rats through predation, competition for food and/or broader ecosystem change. Though uninhabited, Henderson is valued by the Pitcairn Islanders, who will gain widespread recognition for supporting the eradication, and potentially increased revenue from responsible tourism. The Pitcairn Government, and especially the Natural Resources Division, will be key partners in this project.

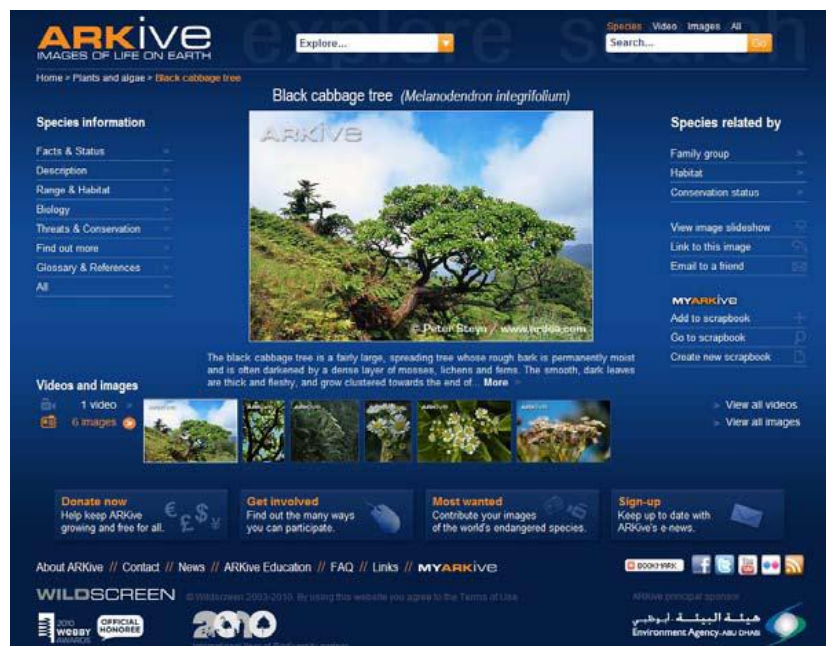
### Identifying Important and Vulnerable Marine Areas for Conservation at South Georgia (OTEP SGS 701)

This project will identify important and vulnerable marine habitats at South Georgia that require conservation in order better to preserve the unique characteristics of this fragile ecosystem. Based on this information, the project team will liaise with the Government of South Georgia & South Sandwich Islands (GSGSSI), the Foreign & Commonwealth Office (Polar Regions Unit), the International Association of Antarctic Tour Operators, NGOs and fishing companies, to develop a representative and comprehensive network of marine protected areas. This will benefit GSGSSI in the sustainable management of the South Georgia Maritime Zone, through the conservation of habitats and species in the context of climate variability and change, and pressures from local, sustainable fisheries and tourism.

Utilising the world's best wildlife films, photographs and audio recordings, Wildscreen will create the UKOT Chapter on ARKive (see [www.arkive.org](http://www.arkive.org)). A minimum of 200 audiovisual species profiles will be created for free use online, with a selection of species profiled on an accompanying free DVD, so that these engaging resources can be used by UKOT environmental educational establishments, especially primary and secondary schools, within all territories. This unique multi-media communications and educational resource will help increase knowledge and understanding of the UKOTs' threatened and endemic biodiversity as well as its value in terms of the essential ecosystems services it provides.
